Supporting Scope 3

Several Scope 3 categories have been enabled through system defined templates, providing the ability to calculate emissions using Climatiq Emission Factors. Additional categories can be defined using the calculation engine. Supported categories include: Purchased Goods and Services; Capital Goods; Upstream Transportation and Distribution; Waste Generated in Operations; Business Travel; Employee Commuting; and Downstream Transportation and Distribution.
